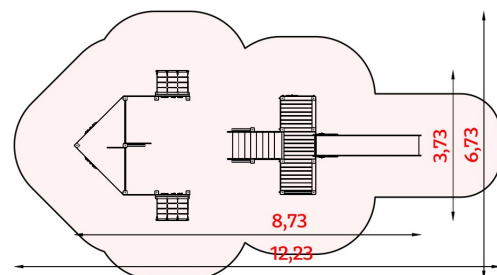

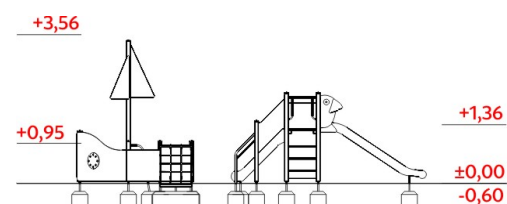
Top view with impact area
